*Chair Marden stated the purpose of this meeting is to perform a Logic and Accuracy Test on voting equipment to be used in the April 14, 2026 Newberry Municipal Election.*

*Chair Marden announced the following rules:*

- The copying, recording, or photography of voter signatures is **prohibited by law**. Anyone in violation will be removed and **not permitted** to return during the election period.
- Members of the public shall not interrupt Canvassing Board meetings, except to make an objection as permitted by law or to respond to an inquiry by the Canvassing Board.
- Phones and other electronic devices must be placed on silent during the Canvassing Board meetings.
- Any individual who violates the procedures or disrupts the canvassing process may be removed.
- Printed copies of the complete Newberry Election Guidelines and Procedures for Observers and Public Inspection are available.

**Logic and Accuracy Test**


**COMMENTS**

The meeting was adjourned at 3:22PM.

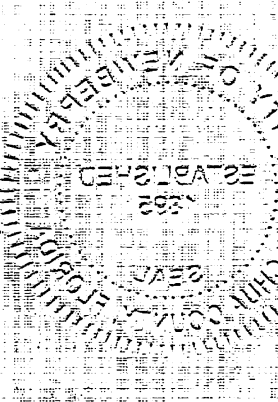
