## **NOTICE TO APPLICANTS FOR PERMANENT SIGN PERMITS**

- 1. The following is required to be submitted with the application for Permanent Sign Permit:
  - a. Site plan/sketch showing proposed placement of the sign on property
  - b. Documentation that:
    - The sign will be professionally made and conform to guidelines as outlined in Section 4.2.20.8 of the Land Development Regulations for the specific zoning district that subject property is located in.
    - ii. The sign will be kept in good repair at all times during its display.
- 2. Permanent signs shall comply with Section 4.2.20 pf the City of Newberry Code of Ordinances.
