# SHED/ACCESSORY BUILDING PERMIT APPLICATION

ALL PERMIT APPLICATIONS SHALL INCLUDE THE FOLLOWING DOCUMENTS AND BE SUBMITTED IN THE ORDER LISTED BELOW. ALL DOCUMENTS MUST BE COMPLETE AND INCLUDED WITH THE APPLICATION PACKET BEFORE THE PERMIT APPLICATION WIL BE PROCESSED.

#### SUBMIT TWO SEPARATE PACKETS:

- 1. Permit application
  - a. Complete and signed.
- 2. Proof of Ownership or Warranty Deed
- 3. Site plan
  - a. Locations of all structures on property, distance to property lines, other structures, utility structures, etc.
- 4. Signed and sealed wind load engineering
  - a. From manufacturer for pre-manufactured sheds.
- 5. Signed and sealed truss engineering (details and layout)
  - a. From manufacturer for pre-manufactured sheds
- 6. Drawings, plans, elevations
  - a. Include uplift, tiedown, and anchor requirements for pre-manufactured sheds
- 7. Florida product approval form and installation instructions
  - a. All windows, exterior doors, garage doors, roofing material, etc.
- 8. Notice of commencement
  - a. Recorded with Alachua County Clerk of Court if project value exceeds \$2,500.00
